I. TAKE CASES

I will accept at least two (2) cases in the following area(s):

Please note that Legal Aid will make every effort to accommodate your choice of subject area, but if no cases are available in that area, you will be contacted to take cases in the areas of greatest need.

Family Law - Last year, there were over 40 parents of minor children who needed assistance with custody. There were over 60 relatives who sought guardianship of family members.

- ___ Dissolution of Marriage (minor children and domestic violence injunction)
- ___ Guardianship of Adult
- ___ Guardian Advocate
- ___ Chapter 751 (temporary custody of minor child by relative)
- ___ Domestic Violence Injunctions

Consumer Law - Last year, there were 90 families who sought bankruptcy assistance, or had other consumer issues.

Housing Law - Last year, we referred 60 families with eviction defenses or conditions and foreclosures.

II. BE A GUARDIAN AD LITEM

This is our area of greatest need. Last year, we received requests for GALs for over 700 children, including children in juvenile dependency cases or child victims, and witnesses in criminal cases.

I will accept at least two cases in the following areas:

Guardian ad Litem - Juvenile Court (you may accept more than one)

- ___ Dependency - Traditional best interests, all ages.
- ___ Transitions cases - Foster teens age 16-21. Special training offered by LAS.
- ___ Appeal cases - Represent or advise GAL on appeal to 5th DCA. Requires additional commitment. Preference given to experienced appellate attorneys.
- ___ Delinquency - Not attorney of record in delinquency, but address best interest issues.

Guardian ad Litem - Criminal Court

- ___ GAL for child victim/witness.
